I acknowledge that I have received all amounts that are now, or in the future, may be due me from the Center. I also acknowledge that during the entire period of my employment with the Center, I received and was paid all compensations, benefits and privileges to which I was entitled under the law, and if I hereafter be found in any manner to have been entitled to any amount, the above consideration is a full and final satisfaction of any and all such undisclosed claims.

3. I will not at any time and in any manner whatsoever, directly or indirectly, disclose to any person or entity any information of any kind relating to the business of the Center, their manner of operations, plans, processes or data of any kind.

4. I warrant that I will institute no action and will not continue to prosecute any pending action, against the Center as well as their successors-in-interest, stockholders, officers, directors, agents or employees, by reason of my past employment with the Center.

5. I finally declare that I have read and fully understand this document, and the release, waiver and quitclaim hereby given is made willingly and voluntarily and with full knowledge of my rights under the law.
